MEMORANDUM CIRCULAR NO. 2016-01

SUBJECT: ADDENDUM TO THE IMPLEMENTING RULES AND REGULATIONS IMPLEMENTING LLDA BR NO. 2007-338, WATER PERMITTING, REGISTRATION AND MONITORING SYSTEM

In order to guide the operating and enforcing unit of the Authority as regards to the operation of water permitting, registration and monitoring system for the extraction of the lake waters of Laguna de Bay and other bodies of waters within the Laguna de Bay, the following guidelines are hereby adopted:

I. Coverage

These guidelines shall apply to all development projects, installations and activities that extract lake waters of Laguna de Bay and other bodies of water within the Laguna de Bay Region.

II. Requirements for Surface Water Permit Application

The documentary requirements stipulated under LLDA Board Resolution No. 362, Series of 2008, "Approving the Implementing Rules and Regulations implementing LLDA Board Resolution No. 2007-338, declaring the establishment and operation of water permitting, registration and monitoring system for the extraction of the lake waters of Laguna de Bay Region and for other purposes" shall only be applicable to all new applications for Surface Water Permit (SWP). For the renewal of applications, only duly accomplished and notarized application form shall be required.

III. Validity of Surface Water Permit

The Surface Water Permit shall be valid for a period of three (3) years, except those entities with existing Concession/Supply Agreement with MWSS, DOE, Water Districts, among others, of which the validity shall be for the duration of said agreement. Moreover, the expiration date of SWP must coincide with the geographical expiration of the Discharge Permit.



Likewise, the SWP shall be subject to suspension, revocation or pre-termination, as the case may be.

IV. Renewal/Revalidation of Surface Water Permit

The SWP must be renewed within thirty (30) days before the date of expiration. If the due date falls on Saturdays, Sundays, or Holidays, payment may be done on the next working day.


Revalidation of SWP shall be within the date specified in the issued SWP.

Failure on the part of the permit holder to renew/revalidate during the specified period shall be subject to administrative fine under LLDA Board Resolution No. 42, Series of 1997.

V. Repealing Clause

All circulars, orders, rules and regulations, memoranda and other issuances inconsistent with or contrary to the provisions of this Circular are hereby repealed or modified accordingly.

This Memorandum Circular shall take effect immediately.
